The parties hereto further agree that all rent above mentioned must be paid in full in advance; no space will be reserved without full payment. The CRAFTER/MERCHANT must have exhibit and equipment properly installed to commence business no later than **3:00 p.m. June 10th, 2026**. In the event the CRAFTER/MERCHANT fails to install equipment and have exhibit in place to commence business as aforesaid, or fails to occupy the space herein leased, all monies paid hereunder shall be retained by TURTLE DAYS.

1. TURTLE DAYS reserves the right to close any exhibit leased herein, without liability, should CRAFTER/MERCHANT, his exhibit, or employees be deemed by TURTLE DAYS to be guilty of any act that is against the best interest of the CHURUBUSCO TURTLE DAYS FESTIVAL.

2. The CRAFTER/MERCHANT agrees to comply with conditions of this contract and all rules and regulations adopted by TURTLE DAYS. Failure to comply may result in cancellation of the lease and CRAFTER/MERCHANT shall forfeit all rights hereunder and shall, upon demand immediately close exhibit and shall surrender the space leased and not be entitled to refund of any monies paid to TURTLE DAYS.

3. TURTLE DAYS will not permit any exhibit to be dismantled before festival closes on Saturday evening, **June 13th, 2026**. Therefore, CRAFTER/MERCHANT agrees to cooperate and obligates them when signature is affixed to this contract.

4. CRAFTER/MERHCANT agrees to assume, defend at all times, indemnify, protect, save and hold harmless TURTLE DAYS, against claims or demands arising or resulting from the use by the CRAFTER/MERCHANT, the claims of any employee or agent of the CRAFTER/MERCHANT, the claims of anyone attending the exhibit and the claims of any other person for damages for bodily injury, sickness, mental anguish, or death and claims for damage to the property of CRAFTER/MERCHANT which is sustained during the use by CRAFTER/MERCHANT of the space provided by TURTLE DAYS.
