Professional Food Vendor Application/Contract

THIS CONTRACT made and entered into this day _____, 2026 by and between CHURUBUSCO TURTLE DAYS ASSOCIATION, INC. (Hereinafter referred to as "TURTLE DAYS"), and

(Hereinafter referred to as "Food VENDOR")

WITNESSETH: TURTLE DAYS during period of the CHURUBUSCO TURTLE DAYS FESTIVAL, **June 10th-13th, 2026** for vending purposes lease: \$350.00 "space". **Please attach your menu and insurance form to this application/contract.**

Upon approval of your application, you will receive a confirmation email with a PayPal link for payment or an option to send a check. Turtle Days will NOT be supplying power to any food vendor. All food vendors must supply own power source.

The parties hereto further agree that all rent above mentioned must be paid in full in advance; no space will be reserved without full payment. The VENDOR must have exhibit and equipment properly installed to commence business no later than **6pm Tuesday, June 9th, 2026**. In the event the VENDOR fails to install equipment and have exhibit in place to commence business as aforesaid, or fails to occupy the space herein leased, all monies paid hereunder shall be retained by TURTLE DAYS.

1. VENDOR must dispose of used frying oil off the premises and make arrangements for the pickup of any other items left on premises at the end of the festival.
2. TURTLE DAYS reserves the right to close any exhibit leased herein, without liability, should VENDOR, his exhibit, or employees be deemed by TURTLE DAYS to be guilty of any act that is against the best interest of the CHURUBUSCO TURTLE DAYS FESTIVAL.
3. The VENDOR agrees to comply with conditions of this contract and all rules and regulations adopted by TURTLE DAYS. Failure to comply may result in cancellation of the lease and VENDOR shall forfeit all rights hereunder and shall, upon demand immediately close exhibit and shall surrender the space leased and not be entitled to refund of any monies paid to TURTLE DAYS.
4. VENDOR must supply certificate of insurance to TURTLE DAYS and must be mailed with this contract.
5. VENDOR must follow guidelines of **Whitley County Health Department -health dept. will be starting inspections at Noon, Wednesday June 10th.**
6. TURTLE DAYS shall not be liable for any damages to VENDOR exhibit, equipment, or merchandise by reason of FIRE, THEFT, LOSS, WEATHER related events, VANDALISM or OTHER damages.
7. TURTLE DAYS will not permit any exhibit to be dismantled before festival closes on Saturday 10pm, **June 13th, 2026**. Therefore, VENDOR agrees to cooperate and obligates them when signature is affixed to this contract.
8. VENDOR agrees to assume, defend at all times, indemnify, protect, save and hold harmless TURTLE DAYS, against claims or demands arising or resulting from the use by the VENDOR, the claims of any employee or agent of the VENDOR, the claims of anyone attending the exhibit and the claims of any other person for damages for bodily injury, sickness, mental anguish, or death and claims for damage to the property of VENDOR which is sustained during the use by VENDOR of the space provided by TURTLE DAYS.
